NEW BUSINESS:

The Board met on August 16th:

- New Membership/Release forms will not be required <u>for continuing members</u> for 2025. Dues checks should be submitted to our Treasurer, Ed Oravec, made out to LHSCG, starting at the November meeting.
- The Board seeks a \$10 increase per household to annual Club dues for 2025, to \$35. This is because of the extreme budget pressure we had at the beginning of 2024 and the desire to continue with certain expenses, such as the Catta Verdera \$800 room charge for our Christmas parties, and to have sufficient reserves for all social events. Increasing the dues requires a change to the Club's Operating Procedure, the COP.
- It would be a lot easier on future VP/Membership Officers if they didn't necessarily have to deal with the actual data entry into our Google contacts, Gmail and group email applications. Members not necessarily on the Board could volunteer to perform this technical task. To allow this, a small change is also needed to the COP.
- The desired changes to the COP are in a separate attachment. This starts the required 30-day comment period. The Members will be asked to approve these changes at the October meeting.
